How Healing Touch is currently being used in your facility:

We began offering HT classes in 1997/98 through the Educational Services Departments apart of CE's for nurses. Since that time we have gained 6 HT practitioners for the Yuma community. Three of those HT Practitioners work here at the hospital. The Staff Chaplains are also trained with at least Level 1 skills.

Currently, integrative therapies are grouped within the Department of Spiritual Care and Patient Advocacy. As a part of my job as Patient Advocate, I coordinate/develop access to integrative therapies such as HT and Guided Imagery. The Palliative Care Team often makes a referral for one of those treatments . Nurses can also ask for a referral for their patients, patients can request a treatment and physicians can and sometimes do write an order for HT for pain management. There are 2 staff nurses who offer HT to their patients when time allows. All treatments are charted in our medical record documentation call a Care Trac. If a physician writes an order for an HT treatment then I will also document in the physician progress note after I have given the treatment. Staff also may ask for a treatment by calling the Spiritual Care Department.
